*Councilmember Nelson spoke about the construction project delay for Scio Church Road. She stated the project should resume again after Labor Day.*

**COUNCILMEMBER EYER**

*Councilmember Eyer stated she plans to bring a proposed Charter amendment resolution to Council at the next meeting. Councilmember Eyer stated her proposal will amend the procurement process outlined in the City Charter to allow for the implementation of the City's responsible contractor policy.*
