Arbor Day 2021: Date: October 1, 2021

The committee will choose between two possible options:

Option 1: Planting 40 Trees in front of 40 Homes: This year marks Ann Arbor's 40th anniversary as a Tree City USA community. In honor of that anniversary, the committee would fund planting 40 trees in front of 40 homes. Residents would sign up for a tree to be planted in front of their home in the right-of-way (ROW). The first 40 residents signed up would be selected, after verification the planting site is suitable for a tree.

Option 2: Pioneer School Planting: The committee would look to partner with the Pioneer High School Ecology club to plant trees in the ROW adjacent to the school on S. 7th Street.
