#### **RMI - Beneficial Electrification**

Ana Sofia and Brett Bridgeland gave a presentation on carbon free buildings. They covered electrification, what electrification looks like and recommendations for Ann Arbor. They covered the Climate, health and consumer protection implications of electrifying your home. They also covered the types of heat pumps, the increased efficiency of heat pumps, and the advancements in technology for heat pumps. They recommended that Ann Arbor look at its building stock and specifically focus on affordable housing that often has resistance heating to start electrifying. They also brought up the importance of job opportunities for creating and developing jobs and prioritize where it makes the most sense to electrify like in new construction. They also offered covered resources for City's looking to incorporate electrification in their community.

Commissioners discussed the role of renewables and energy efficiency, the role of the utilities, and the role of the government in electrification. They also discussed fees that promotes electrification and other ways to promote electrification and renewables more generally with new builds and existing housing stock.

#### SolarFaithful Presentation

Murray Rosenthal presented the solar faithful model. A local house of worship, Genesis, took part of the Solar Faithful program that Murray now helps to run. He also covered the motivation for Genesis to pursue solar and the the specifics of the system, how they created the program through the power purchase agreement, the need for an LLC along with information on how to capture the federal tax credit along with resources for those interested that can be found on Michigan Interfaith Power and Light's website.

Commissioners expressed gratitude for Murray's work in the community.
