- 8-a. 22-0895** 330 Detroit Street Site Plan for Planning Commission Approval - Two existing buildings are proposed to be removed to accommodate a 5-story building that includes 14 residential units, 23 on-site parking spaces, and 1,850 square feet of ground floor retail space. Pedestrian and vehicular access will be from N. Fifth Avenue and Detroit Street. Zoning is D2 (Downtown Interface) the lot size is 9,879 square feet (0.23-acre parcel) and the site is located at 303, 312 and 314 Detroit Street. Staff Recommendation: Approval

STAFF REPORT:

Matt Kowalski, City Planner, was available for comments and questions.

PUBLIC HEARING:

Matthew Banks, Detroit Street Filling Station – Looking forward to working with development team on their terrific building. Our concerns are about our operation during the building is under construction. We are veterans of construction. Losing utilities is a huge problem for us, we support a lot of people that can't. Looking for a voice on construction staging, including hours, noise, etc. MAV has been very straightforward and understanding. We want everyone to do well.

Lisa Young, Chair of the Market Advisory Commission, read (attached) letter from Ms. Goetz. The construction phase of this could be adverse to the market. Many of the businesses in the city were lost in the City. If the City sees fit to approve, this should include Fifth Street for phasing and limited construction during mealtimes. It should not be developed at the sacrifice of these existing businesses.

Chair of the Public Market Commission – We are concerned about the construction phase of the project. The Ann Arbor farmer's market has been the heart of the local food economy for a century, and supports food and farming businesses. We are concerned about the construction, not the building. The construction should be minimized in the following ways. Develop a plan in conversation and regular meetings and pay specific attention to parking on Detroit Street.

Ken Garber, 28 Haverhill Court, Ann Arbor, urged the Commission to take the concerns of the public regarding construction staging. He read from a prepared statement, noting the proposed project will be LEED Gold, geothermal heating and cooling, and operable windows. Geothermal was not presented during the presentation this evening. Does the petitioner still intend to use geothermal heating. LEED gold does little by itself as compared to electrification.

Stefanie Stauffer, Market Manager – Want to highlight concerns about staging in Detroit Street as part of our market. Want to make sure no construction is happening during the Wednesday and Saturday markets.

We also use Detroit Street for our vendors to park and unload their facilities. Want to make sure this project doesn't have a detrimental impact on the market.

Seeing no further speakers, Vice-Chair Gibb-Randall closed the Public Hearing.

Moved by Wonwoo Lee, Seconded by Sara Hammerschmidt, that the Ann Arbor City Planning Commission approves the 330 Detroit Site Plan (303 Detroit Street) dated March 22, 2022, as the site plan complies with all applicable requirements of the Unified Development Code, and other applicable laws, ordinances, standards, and regulations.

8-b. [22-0896](#) Proposed Amendments to Ann Arbor City Code Chapter 55 Unified Development Code - Amendments to the Unified Development Code

(UDC) Sections 5.16.1.A (Residential Occupancy), 5.16.2.A and B (Adult Day Care Center, Child Care Center), 5.16.3.J (Outdoor Recreation), 5.16.3.P (Transit Corridor Development), 5.16.4.B (Nonprofit Corporations), 5.16.6.C (Drive-Through Facilities), 5.16.6.G (Group Day Care Home), and Section 5.19 (Parking Standards) are being considered to eliminate minimum parking requirements for all uses, eliminate or consolidate some parking use categories, eliminate the option for off-site bicycle parking, change the weight limit for vehicles parked in driveways, simplify the requirements for electric vehicle parking, and change, reformat, and include the TC1 district in the special parking district regulations. These changes will enable reduced impervious surfaces, encourage land to be used more efficiently, incentivize the construction of new residential uses, reduce the cost of constructing new residential uses, and support transit services. Staff Recommendation: Approval
