Discussion on Neighborhood Crosswalk Design

A. Gossage discussed the Neighborhood Crosswalk Design. CM Griggs reached out to Commissioner Gossage concerning the installation of crosswalks. The question; are the crosswalks accessible as they should be? The crosswalks may be compliant with ADA, but are they best practices? The concern is with the curb cut at Arborview and Leslie, that they do not provide enough information, the intersection is directly across the street. Therefore, the commission would like to draft a Resolution to share with City Council to look at best practices when installing curb cuts and other construction work related to ADA. M. Solomon moved that the commission object to the current construction that exist at the intersection of Arborview and Leslie that it is not fully accessible and that it be remediated immediately and submit a Resolution to make changes in the future. Every construction project needs to be vetted by CODI. Seconded by L. Keeler. Motion carried. A. Gossage will draft a Resolution and send to commissioners for review. L. Keeler will report the commission concerns to the Transportation Commission.
