TRANSPORTATION COMMISSION UPDATE - LARRY KEELER

L. Keeler provided an update on the Transportation Commission.

November- The 2023 meeting calendar passed. The commission is looking for alternative proposals for propulsion batteries and hybrid systems for buses. A resolution passed that is going to City Council requesting more money for APS and curb cuts. The commission will review the new crash report-speed management devices to deflect traffic. Street resurfacing is almost complete. AAATA is discussing increasing some of their routes to later in the evening. December- The commission has a new City Council Liaison Dharma Akmon. The commission will review the work plan for the 7th street construction and crosswalk designs. A new APS has been installed at Huron and Seventh and Jackson Ravino. The annual report was reviewed. K. Mozak suggest the commission review the AAATA propulsion information at TheRide.org.

U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE

M. Solomon provided an update on the Council for Disability Concerns. Christina Klein longtime ADA coordinator is leaving for a position at Duke University. Replacement to be determined. ECRT services is one of the initiatives she spearheaded-this will allow anyone having an event to receive full sign language interpretation for their event in advance. ECRT pilot program will run for two years. Discussion on Ann Arbor's ADA coordinator position, job description, posting and hiring practices.

CITY PERSONNEL REPORT - DENISE JEANES

D. Jeanes gave an update on the latest hires and retirement at City Hall.

CHAIR REPORT - ZACH DAMON

Z. Damon gave the chair report. The commission is encouraged to participate with "Nothing About Us Without Us" film festival. This festival is disability focus including partners from the Center for Independent Living. These films put in the forefront disability, equity and inclusion. They are accepting submissions now. Z. Damon will update the commission when more information is available.
