#### **22-0240** ICPOC January Meeting Minutes

A motion was made by R. Milgrom and seconded by S. Carter, that the Minutes be Approved by the commission and forwarded to the City Council and should be returned by 03/07/2022. On a voice vote, the Chair declared the motion carried.

#### **OLD BUSINESS**

#### **Review of Past Complaints 2020**

F. Todoro-Hargreaves reported on the status of the 2020 complaints. They are all completed with the exception of one where the commission has extra comments and recommendations. The commission concur with the finding of the Professional Standards division. The information managers review team meet monthly with AAPD deputy chiefs to review complaints.

#### Plan for 2021 Complaints

F. Todoro-Hargreaves reported the complaints for 2021 will start review next week. The goal is to complete all complaints by June 2022. The commission is working with IT to create a dashboard to review complaint status on their webpage.

ICPOC welcome their new intern Debra Erickson from U of M school of social work. She will assist the review team with finalizing the complaint process and procedures.

#### **Ann Arbor Traffic Transparency Resolution**

L. Jackson discussed the draft Traffic Transparency Resolution. Council liaisons were asked about a time frame to draft an Ordinance? CM Ramlawi suggested ICPOC draft the ordinance during council's budget season. CM Song will reach out to the City Attorney's and Administrator's offices for a time frame before the next meeting. A four month timeline was discussed. The commission would like AAPD to make public the information they collected and create an annual report to share with the community. The commission is currently asking for duration of traffic stops and the frequency of pullovers from AAPD. S. Carter motion AAPD comment on the items requested, if the information is available now, and the AAPD consult with their departments and report back to the commission; move that the resolution be tabled and rescheduled for final approval at the March meeting. Motion carried.

#### **NEW BUSINESS**

#### Alternative to Police as First Responders

L. Jackson reported CROS Coalition A2 Public Forum on Wednesday,

February 16, 2022 at 7:00 p.m. ICPOC was asked to write a resolution if they're in support of Unarmed Response. L. Jackson noted there is no need when the Mayor included ICPOC in his resolution. F. Todoro-Hargreaves would like to know the timeline when the city will begin the public feedback meetings? CM Song will check on the status. M. Othman moved that ICPOC support the City of Ann Arbor Council Resolution R21-129 on Unarmed Response, seconded by M. Shipp. Motion carried.

#### **Meeting with Police Officers Union**

F. Todoro-Hargraves reported on the meet and greet with the Police Officers Union. Also in attendance were commissioners; M. Othman, B. Billups and S. Carter. They discussed unarmed response, challenges with staffing and recruiting in the AAPD and ideas on different types of outreach.

#### **Relationship Policing**

F. Todoro-Hargreaves reported exploring relationship policing with AAPD and ICPOC commissioners. Moving forward the commissioners would like to keep the lines of communication open, and meet with officers on a regular bases.

B. Billups remind commissioners to sign-up for a Ride-along with the AAPD. M. Othman reported on AAPD new project CPOT (community partnership and outreach team) part of their community engagement outreach.
