Unarmed Response - Lisa Jackson, Chair, ICPOC

## Resolution Call for an Ordinance to Collect and Make Available Traffic-Stop Data

*Dr. Jackson discussed the AAPD's collection of traffic stop data from the years 2017 through 2019, the open source data research being done by* 

the Southeast Michigan Criminal Justice Policy Research Project SMART, and the need to continue to collect such data and make it available to the public. A question and answer period followed. The HRC's resolution on this subject passed on unanimous vote and will be sent to City Council.
