Their new co-chair was introduced, Colleen Van Lent, Lecturer in the School of Information, she teaches web design and a member of the student IDEA board. She gave an update on parking accessibility - specifically at the Natural History Museum, concerns about pick-up and drop-offs and other safety issues. LSA has a new program-Disability Navigators they're working with the DEI office and LSA-HR. They have set goals for the first 90 days. They met with U of M council and want to meet with leaders and disability advocates to help understand disability culture at U of M. K. Mozak expressed her disappointment at this year's Super Bowl regarding interpreters and the deaf community. Next meeting Tuesday, March 8th via zoom.
