Whereas, the total annual precipitation in Ann Arbor has increased 44% between 1951 and 2012;

Whereas, climate models predict Ann Arbor will experience an additional 2-4 inches of rainfall each year, increased drought, more consecutive high-heat days, and shorter winters;

Whereas, on December 17, 2012, the Ann Arbor City Council adopted the Ann Arbor Climate Action Plan that calls for the integration of climate adaptation into city operations to build resilience, prepare for extreme events, and prevent future negative outcomes;

Whereas, the Mayor of Ann Arbor has signed on to the Compact of Mayors, an international compact that commits cities to assessing vulnerabilities to climate change and developing and pursuing adaptation strategies to minimize these vulnerabilities;

Whereas, Ann Arbor's current adaptation practices and policies to build climate resilience are not

consistently coordinated across service areas;

Whereas, climate adaptation is not consistently considered in major projects, such as master planning, hazard mitigation, and capital planning;
