Attached for your consideration is a resolution to approve the closing of certain streets for the Shamrocks and Shenanigans 5K Run/Walk on March 10, 2024.

The event will run from 9:45 AM to 11:30 AM and will require closing of the following streets from 8:00 AM to 11:30 AM on March 10, 2024 :

- S. Main from Stadium to West Jefferson
- Madison from South Fourth to Main

- West Washington from South First to South Ashley
- South Ashley from West Jefferson to West Washington
