Resolution Authorizing Summary Publication of Ordinance 23-32 - An Ordinance to Amend Sections 5.17.4 and 5.18.6 of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor (Premiums, D1 and D2 Floor Area Ratio)

The attached resolution is contingent upon Council approval of Ordinance 23-32 at second reading on December 4, 2023. The City Charter allows summary publication of ordinances that are in excess of 500 words in length upon approval by City Council. RESOLVED, That the publication of Ordinance 23-32 shall be made by the following summary:

Ordinance 23-32 repeals Section 5.18.6 in its entirely, eliminating the premium floor area options that offer increased floor area when certain amenities are provided, and amends Table 5.17-4 in Section 5.17.4 (Mixed Use Zoning Districts) to change the maximum FAR (floor area ratio as a percentage of lot area) of the D1 and D2 districts to "none."
