First Quarter 2008 Investment Portfolio Report

Attached for your information is the City's investment portfolio report for the first quarter 2008. At March 31, the portfolio calendar year-to-date return on investments net of fees was 4.43%. The quarterly return on investments net of fees was also 4.43%. The weighted average yield for the portfolio for the period was 4.40%, which exceeded the 12-month trailing rate of the 2-year Treasury Note as of March 31 (3.69%) by 71 basis points. The weighted average effective maturity at quarter end was 548 days.

The Governmental Accounting Standards Board requires under Statement 31 that all investments be recorded at fair value versus amortized cost. At quarter end, the amortized cost value of the portfolio was \$174,267,482.69. If investments were recorded using the fair value method, the value of the portfolio would be \$179,488,169.69. Recording investments at fair market value, the portfolio experienced an unrealized gain of \$5,220,687.00.
