Resolution Authorizing Sanitary Sewer and Water Improvement Charges for 1288 Broadway Street (\$23,310.60)

Your approval is requested to levy the sanitary sewer and water improvement charges of \$23,310.60 on the property known as 1288 Broadway Street. The parcel is a result of a property split in 2007 from the parent parcel of 1300 Broadway Street. The applicable connection charges have been paid and the property is "active" for sanitary sewer and water service as of June 3, 2008.

According to current procedures, the property owner needs to now pay the property's share of the existing utilities through the City improvement charge levy as required under section 1:278, Chapter 12, of the Ann Arbor Code. The \$23,310.60 Utilities Improvement Charge is to be levied and then made payable in 15 annual installments at 5.270% interest per annum on the unpaid balance.

It is therefore recommended that Council levy this improvement charge according to the terms described above.

1. That Council levy an improvement charge against the following property which is specifically benefited by the above improvements:

2. That the improvement charge levied be \$23,310.60;
3. That this improvement charge be divided into 15 equal installments; the first to be due on September 4, 2008, and the 14 subsequent installments to be due on June 1 of each and every year thereafter, with the deferred installments of the improvement charge to bear interest at the rate of 5.270% per annum commencing September 4, 2008;
4. That the Public Services Area be directed to send a copy of this resolution by first class mail to the owners of the property and to promptly have this resolution recorded in the office of the Register of Deeds of Washtenaw County, Michigan; and
5. That this levied improvement charge be invoiced to the owner, Yong Yi Huang, of the property known as 1288 Broadway St, City of Ann Arbor, Washtenaw County, Michigan 48105, and to be invoiced at 1300 Broadway Street, Ann Arbor, MI 48105, and to be credited in the amount of \$17,396.79 to Fund 0043-073-8000-7151 and \$5,913.81 to Fund 0042-073-8000-7151.
