Resolution Authorizing the Purchase of Materials used for Maintenance Activities within Field Operations Utilizing Governmental Pricing extended by Stoneco of Michigan (\$75,000.00) Attached is a resolution for your approval for the purchase of materials from Stoneco of Michigan. These materials are used for normal maintenance activities such as watermain breaks and street repairs.

The Washtenaw County Road Commission solicited bids for operating materials and Stoneco of Michigan was the lowest responsible bidder. Stoneco of Michigan has agreed to extend the governmental pricing to the City of Ann Arbor. Below is an estimate of the City's expected purchase of materials through June 30, 2011.
