Resolution to Approve an Amendment to an Agreement with DTE Gas Company at 841 Broadway for the Allen Creek Railroad Berm Opening Project (8 Votes Required)

On March 18, 2019, R-19-115, City Council approved an Agreement with DTE Gas Company for Storm Water and Sidewalk Easements and a Temporary Construction Permit ("Agreement") for the Allen Creek Railroad Berm Project. The Agreement was recorded April 1, 2019 in Liber 5297, page 725 and April 15, 2019 in Liber 5299, page 354, Washtenaw County Records.

The project has required more temporary construction area than originally anticipated, therefore the parties would like to amend the Temporary Construction Permit portion of the Agreement to allow the City and its contractors additional temporary construction area consistent with the attached drawing.
