Resolution Recognizing The Word of Life DBA: University Christian Outreach as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

The Word of Life DBA: University Christian Outreach is a 501(c)3 civic nonprofit organization that is dedicated to changing campus communities to change the world, working with students at the University of Michigan, Eastern Michigan, and Washtenaw Community College.

Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
