Resolution to Approve Street Closings for the UA Plumbers & Pipefitters Block Party - Monday, August 14, 2023

Attached for your consideration is a resolution to approve the closing of S. Main between Liberty and William from 10:00 A.M. to 11:00 P.M. on Monday, August 14, 2023 to stage the UA (United Association) Plumbers & Pipefitters Block Party. The actual event will take place from 6:00 P.M. until 10:00 P.M. with the additional time to be used for set-up and break-down of the event.

This event, sponsored by the Ann Arbor Area Convention and Visitors Bureau (AAACVB), is also intended to attract people to the downtown area to enjoy the festivities. Live entertainment will be provided from 6:30 P.M. and will conclude by 10:00 P.M.

The sponsor will submit an application for approval from the State of Michigan Liquor Control Commission for temporary sales, service and consumption of alcoholic beverages in the defined areas pursuant to the M.L.C.C. regulations.

Notification of the street closings will be provided through the City's website and GovDelivery. The Sponsor will also provide information to all UA members via the internet, AAACVB website, MLive.com, as well as hotels, area churches and merchants no less than two weeks prior to the event.
