STATE AND ELLSWORTH PLAZA ZONING (3965 SOUTH STATE STREET)

AN ORDINANCE TO AMEND THE ZONING MAP BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR.

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the Southwest corner of Section 9, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan; thence N 1°-05' W 183.01 feet along the West line of said section and the centerline of South State Street; thence N 87°-53'-20" E 33.0 feet for a PLACE OF BEGINNING; thence along the East line of South State Street and the existing city limits of the City of Ann Arbor N 1°-06' W 64.49 feet; thence N 87°-53'-20" E 495.0 feet along said city limits; thence S 1°-06' E 214.50 feet along said city limits; thence S 87°-53'-20" W 344.99 feet along said city limits and the North line of Ellsworth Road; thence N 1°-06' W 150.01 feet; thence S 87°-53'-20" W 150.01 feet to the Place of Beginning, being a part of the SW ½ of Section 9, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan,

in the City of Ann Arbor, Washtenaw County, Michigan as C3 (Fringe Commercial District).

Section 2. This ordinance shall take effect and be in force on and after ten days from legal publication.
