Resolution Accepting Annual Renewal Recommendation of the Council Liquor License Review Committee

Whereas, The Council Liquor License Review Committee has completed its annual review of onpremises liquor licenses in accordance with Section 9:79 of the Ann Arbor City Code; Whereas, After investigation and receipt of recommendation from City service areas, the Council Liquor License Review Committee recommends non-renewal of the on-premises liquor licenses for the following license holders:
