Resolution Authorizing Road Improvement Charge for 3091 Glazier Way (\$19,064.95)

Your approval is requested to levy road improvement charges of \$19,064.95 on the property known as 3091 Glazier Way. In order to receive City utility services, the owner requested annexation from Ann Arbor Township, which was completed on December 27, 2007, as notified by the State of Michigan. The property has paid the applicable connection and utility improvement charges, and is "active" for sanitary sewer and water service as of September 21, 2005. Glazier Way was improved as part of the 2000 Glazier Way Road Improvement Project that included pavement, curb & gutter, streetlights, sidewalks, water main, sanitary sewer, and storm sewer.

The property owner needs to now pay the property's share of the existing improvement charge through the City improvement charge levy as required under section 1:278, Chapter 12, of the Ann Arbor Code. The \$19,064.95 Improvement Charge is to be levied and then made payable in 15 annual installments at 7.0% interest per annum on the unpaid balance.

It is therefore recommended that Council levy the improvement charge according to the terms described above.

- 2. That the improvement charge levied be \$19,064.95;

That this improvement charge is divided into 15 equal installments; the first to be due on June 1, 2008, and the 14 subsequent installments to be due on June 1 of each and every year thereafter, with the deferred installments of the improvement charge to bear interest at the rate of 7.0% per annum commencing June 1, 2008;
- 4. That the Public Services Area be directed to send a copy of this resolution by first class mail to the owners of the property and to promptly have this resolution recorded in the office of the Register of Deeds of Washtenaw County, Michigan; and
- That this levied improvement charge be invoiced to the owners, Richard E. Ratliff & Lindsay A. Olson (husband & wife), of the property known as 3091 Glazier Way, City of Ann Arbor, Washtenaw County, Michigan 48105, and to be credited in the amount of \$19,064.95 to Fund 0062-040-4599-7151.
