An Ordinance to Amend Section 7.34 of Chapter 77 (Fees and Bonds Required) of the Code of the City of Ann Arbor (Ordinance No. ORD-19-39)

The City's fee schedule for Going out of Business permits is currently set at \$115.00. However, PA 39 of 1961 sets the maximum fee for these local permits at \$50.00. The proposed ordinance amendment to Section 7.34 of Chapter 77 will bring the City's permit fees for Going out of Business Sales in line with the State's statue, MCLA 442.216(3).
