Whereas, The territory hereinafter described is located in the Township of Ann Arbor and is adjacent to the corporate limits of the City of Ann Arbor;

Whereas, Steven C. and Marcia Althoen are the owners of said property; and

Whereas, It is the desire of Steven C. and Marcia Althoen to annex said territory to the City of Ann Arbor, pursuant to the provisions of Act 359 of the Public Acts of the State of Michigan for the year 1947, as amended;

RESOLVED, That the following described lands and premises situated and being in the Township of Ann Arbor, Washtenaw County, Michigan, be detached from said Township of Ann Arbor and annexed to the City of Ann Arbor, to-wit:

Commencing at the Southeast corner of Lot 12, HILLTOPS SUBDIVISION, as recorded in Liber 9 of Plats, Page 52, Washtenaw County Records; thence N 01 degrees 08 minutes 00 seconds East 374.16 feet along the East line of said subdivision; thence North 89 degrees 42 minutes 30 seconds West 190.88 feet (measured as 191.94 feet);

thence South 03 degrees 07 minutes 00 seconds West 15.02 feet for a Place of Beginning; thence continuing South 03 degrees 07 minutes 00 seconds West 306.98 feet; thence nontangentially along the arc of a circular curve concave to the south with a radius of 1179.28 feet, the chord which bears North 81 degrees 30 minutes 00 seconds West 175.61 feet; thence North 00 degrees 00 minutes 00 seconds East 281.64 feet along the East line of Sumac Lane; thence South 89 degrees 42 minutes 30 seconds East 190.05 feet to the Place of Beginning. Being a part of Lots 12 and 13, HILLTOPS SUBDIVISION, a recorded subdivision of part of the West half of the West half of the Southeast quarter of Section 26, town 2 South, Range 6 East, Ann Arbor township, Washtenaw County, Michigan, as recorded in Liber 9 of Plats, Page 52, Washtenaw County Records.
