Whereas, Pursuant to Public Act 198 of 1974, as amended, ("the Act") the City Council has the authority to establish "Industrial Development Districts" within the City of Ann Arbor;

Whereas, On May 19, 2010, Green Road Associates requested the City establish a new Industrial Development District on its property located in the City of Ann Arbor comprised of land being more particularly described in Attachment 1;

Whereas, Construction, acquisitions, alterations or installation of proposed real and personal property by Green Road Associates or NanoBio, Inc. has not commenced at the time of filing the request to establish this district; and

Whereas, The Act requires that City Council set a public hearing to receive comment on the proposed new Industrial Development District No. 2010-010 and provide notice of the public hearing by mail to all owners of real property located within the proposed district and to the public by

newspaper advertisement or public posting on the establishment of the proposed district;

RESOLVED, That the City Council of the City of Ann Arbor hereby sets a public hearing for July 6, 2010 at 7:00pm or as soon thereafter as it may be convened in the City Council Chambers, 2<sup>nd</sup> floor, Guy Larcom Municipal Building, 100 N. Fifth Avenue to receive public comment on the proposed new Industrial Development District No. 2010-010 as described in Attachment 1 to this Resolution; and

RESOLVED, That the City Clerk be directed to publish notice of public hearing in a newspaper of general circulation in the City and mail notice to all owners of real property located within the proposed district as indicated by the records of the City Assessor.
