Resolution to Modify Amendments to Solid Waste Regulations Filed with the City Clerk January 22, 2008, as Revised and Filed February 4, 2008 (City Council Modifications as Revised for April 7, 2008)

Whereas, The City Administrator submitted proposed amendments to the City’s Solid Waste Regulations to the City Council at its January 7, 2008, meeting and filed the proposed amendments with the City Clerk on January 22, 2008;

Whereas, The City Administrator revised the proposed amendments to the Solid Waste Regulations and filed the proposed amendments, as revised, with the City Clerk on February 4, 2008;

Whereas, Section 2:10 of Chapter 26 of the City Code provides that solid waste regulations take effect 30 days after they are filed with the City Clerk, unless disapproved or modified by City Council;

Whereas, Members of City Council have concerns about some of the proposed amendments to the Solid Waste Regulations and wish to have the City Council consider modifications to the proposed amendments;

Whereas, Members of City Council initially introduced proposed modifications at the February 4, 2008, City Council meeting, but have revised those proposed modifications for consideration at the April 7, 2008, City Council meeting; and

Whereas, Copies of the amendments to the Solid Waste Regulations that were filed by the City Administrator on February 4, 2008, and of the modifications proposed by members of City Council, as revised for April 7, 2008, are attached;

RESOLVED, That the proposed amendments to Section (4) of R2:2 and Paragraph (A) of Section (2) of R2:5 be modified to eliminate the proposed change from November 30 to October 31 with the additional week of collection after Thanksgiving so that these subsections will read:

R:2.2 (4) The seasonal weekly curbside compostable collection program is operated from April 1 through November 30~~[October 31<sup>st</sup>. One additional week of compostable collection is provided starting the Monday after Thanksgiving].~~

R2:5 (2) (A) Residents with curbside refuse collection receive weekly compostable collection from April 1 through November 30~~[October 31<sup>st</sup>. One additional week of compostable collection is provided starting the Monday after Thanksgiving].~~

RESOLVED, That Paragraph (D) of Section (2) of R2:5 be modified to read:

(D) Each ~~[filled container,]~~ bag or bundle may weigh up to 50 pounds.

RESOLVED, That Paragraph (H) of Section (1) of R2:5 be modified to read:

R2:5 (1) (H) The fees for the cost and delivery, servicing, and replacement of [~~refuse and compostable~~] curbcarts will be determined by City Council resolution and will be invoiced to the property owner. Nonpayment of the invoice will result in the costs being assessed against the property owner pursuant to section 2:5 of Chapter 26.

RESOLVED, That the amendments to the Solid Waste Regulations, as modified, be approved; and

RESOLVED, That, as provided in Section 2:10 of Chapter 26 of the City Code, the amendments to the Solid Waste Regulations, as modified, take effect in thirty (30) days.
