Resolution Recognizing Vocal Arts Ensemble of Ann Arbor as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Vocal Arts Ensemble of Ann Arbor is a 501(c)3 civic nonprofit organization that performs a highly varied repertoire of choral music, collaborates with other local performing artists and seeks to educate and entertain people of all ages.

Passage of the attached resolution will allow the Vocal Arts Ensemble of Ann Arbor to hold a raffle, wine pull and a silent auction at The Ark, located at 316 S. Main Street. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.

Whereas, Vocal Arts Ensemble of Ann Arbor has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and

Whereas, Vocal Arts Ensemble of Ann Arbor is a local civic nonprofit organization as defined by P.A. 382 of 1972, as amended, which should be recognized for its highly varied repertoire of choral music, collaborates with other local performing artists and seeks to educate and entertain people of all ages;
