Resolution Authorizing Summary Publication of Ordinance No. ORD-10-18 Amending Section 1:572 (b) of Chapter 18, Title I of the Code of the City of Ann Arbor to Increase Non -Union Employees Contributions to the City of Ann Arbor Employees Retirement System

The attached resolution authorizes the summary publication of Ordinance No. ORD-10-18 which amends Section 1:572(b) of Chapter 18, Title I of the Code of the City of Ann Arbor by adjusting the contributions of members who are non-union employees. Effective July 1, 2010, the contribution rate for those members shall be increased from 5% to 6% of the compensation paid by the City. The amendment will affect only non-union employees.

The City Charter contains provisions to allow summary publications of ordinances that are in excess of 500 words in length. The purpose of this resolution is to lessen the City's cost resulting from the required publication of the revisions to the City Code.

RESOLVED, That Ordinance No. ORD-10-18 be published by the following summary:

Ordinance No. ORD-10-18 amends Section 1:572(b) the City Code by adjusting the contributions of members who are non-union employees. Effective July 1, 2010, the contribution rate for non-union employee members shall be increased from 5% to 6% of the compensation paid by the City.
