Whereas, St. Francis of Assisi Ann Arbor, a Michigan nonprofit corporation, is the owner of property

commonly known as 2221 Winchell Drive, Ann Arbor, Michigan 48104; and

Whereas, Grantor has signed a grant of easement for water main and appurtenances as described below and on the attached map:

A Water Main Easement located within Lot 9 of Assessor's Plat Number 49, recorded in Liber 17, Pages 33 and 34, of Washtenaw County Records, in the City of Ann Arbor, Washtenaw County, Michigan, and is more particularly described as: Commencing at the Northeast corner of said Lot 9; thence South 31° 48' 20" West, along the Northwesterly right of way line of St. Francis Drive, 143.25 feet to the Point of Beginning of this Water Main Easement; thence South 31° 48' 20" West, continuing along the Northwesterly right of way line of St. Francis Drive, 40.00 feet; thence North 58° 04' 05" West, 266.08 feet; thence South 31° 55' 55" West, 14.98 feet; thence North 58° 04' 05" West, 40.00 feet; thence North 31° 55' 55" East, 14.98 feet; thence North 58° 04' 05" West, 218.91 feet; thence South 33° 13' 26" West, 136.07 feet; thence South 77° 33' 25" West, 39.69 feet; thence North 58° 06' 36" West, 63.88 feet; thence South 32° 20' 50" West, 77.38 feet; thence South 21° 05' 50" West, 9.28 feet; thence South 01° 24' 10" East, 97.42 feet; thence North 87° 10' 09" East, 148.59 feet; thence
