Resolution to Approve Street Closing for Mission Zero Fest, June 9-10, 2012

Attached for your consideration is a request from the Mission Zero Fest, the sponsor, to close Fountain Street between Hiscock and West Summit from Friday, June 8 at 8:00 A.M. to Monday, June 11, 2012 at 6:00 P.M. for the Mission Zero Fest. The event itself will run from June 9 through June 10. This event is intended to unleash the power of innovation and imagination to create a future of sustainability, economic opportunity and ecological regeneration.
