Whereas, Johnson Building Group, LLC is the owner of property commonly known as 490 Huron

Parkway, more fully described at Liber 4874, Page 65, Washtenaw County Records; and

Whereas, Johnson Building Group, LLC, has executed and delivered a grant of easement for public utilities, being more particularly described as:

Commencing at the West 1/4 corner of Section 26, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan, thence S 89°43' E 738.33 feet along the East -West 1/4 line of said Section 26 to the Place Of Beginning; thence 130.34 feet along the East right of way line of Huron Parkway, the arc of a circular curve to the left, with a radius of 4845.00 feet, and a chord of N 13°35'33" W 130.34 feet; thence N 74°08'00" E 116.46 feet; thence 28.37 feet along the arc of a circular curve to the right, with a radius of 230.00 feet, and a chord of N 77°40'02" E 28.35 feet; thence N 80°18'54' E 94.49 feet; thence S 60°41'50" E 3.48 feet; thence S 15°02'44" E 14.78 feet; thence S 75° 02'53" W 239.85 feet: thence S 17°36'03" E 73.11 feet; thence S 55°22'18" E 58.34
