Resolution to Approve Amendment No. 2 to the General Services Agreement with The Davey Tree Expert Company for Routine Street Tree Pruning & General Forestry Services (\$295,050.00 Amendment, \$837,281.00 Contract Total, RFP #23-30)

Attached for your review and action is Amendment No. 2 to General Services Agreement with The Davey Tree Expert Company (Davey) for routine street tree pruning and on-call general forestry services (A2-0000898).

On August 7, 2023, City Council approved Resolution R-23-283 approving a General Services Agreement with The Davey Expert Tree Company for routine street tree pruning and general forestry services. Staff have found the need for additional support for forestry maintenance activities and pruning for approved FY2024 Engineering construction projects.

Amendment No. 2 adds an additional funding amount of \$295,050.00 to the contact (Article 5, COMPENSATION OF CONTRACTOR) to complete additional forestry maintenance activities and engineering project tree trimming for FY2024 construction projects.

The new contract total including this amendment shall not exceed \$837,281.00.

Whereas, The Davey Tree Expert Company complies with the City's non-discrimination and Living Wage Ordinances;

RESOLVED, That City Council approves Amendment No. 2 to the General Services Agreement with The Davey Tree Expert Company in the amount of \$295,050.00 for additional support for forestry maintenance activities and pruning for approved FY2024 Engineering construction projects;

RESOLVED, That the Mayor and City Clerk be authorized and directed to execute said contract after approval as to form by the City Attorney and approval as to substance by the City Administrator; and

RESOLVED, That the City Administrator be authorized to take the necessary administrative actions to implement this resolution.
