Whereas, Capovista, LLC, a Michigan limited liability company is the owner and Craig Lorenz and Sarah Lorenz are the land contract vendees of property commonly known as 1780 Scio Church Road, Ann Arbor, Michigan 48103, described at Liber 4869, page 902 of Deeds, Washtenaw County Records; and

Whereas, Capovista, LLC, owner, and Craig Lorenz and Sarah Lorenz, land contract vendees, have signed a grant of easement for public right-of-way, described as:

BEGINNING AT THE SOUTH 1 / 4 CORNER OF SECTION 31, T2S-R6E, CITY OF ANN ARBOR, WASHTENAW COUNTY, MICHIGAN; THENCE S87°25'32"W 38.79 FEET ALONG THE SOUTH LINE OF SAID SECTION 31; THENCE N01°21'50"W 50.01 FEET ALONG THE EAST LINE OF "LANDMARK MAPLE SUBDIVISION", LIBER 25 PAGES WASHTENAW COUNTY **RECORDS:** OF PLATS. 66-68. THENCE N87°25'32"E 37.71 FEET; THENCE N87°22'01"E 99. 77 FEET; THENCE S01°21 '50"E 50.01 FEET; THENCE S87°22'01"W 98.69 FEET ALONG THE SOUTH LINE OF SAID SECTION 31 TO THE POINT OF BEGINNING.
