Resolution Recognizing Allen Creek Preschool as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Allen Creek Preschool is a 501(c)3 civic nonprofit organization that supports the health and growth of children in an environment that promotes emotional, intellectual and interpersonal understanding.

Passage of the attached resolution will allow the Allen Creek Preschool to hold a raffle and silent auction at 102 S. First Street in Ann Arbor. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.

Whereas, P.A. 382 of 1972, as amended, requires that local civic nonprofit organizations be recognized by resolution adopted by the local governmental subdivision in which the organization conducts its principal activities and that a copy of said resolution be filed with any application for a license to conduct a bingo, raffle or charity game(s);

Whereas, Allen Creek Preschool has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and

Whereas, Allen Creek Preschool is a local civic nonprofit organization as defined by P.A. 382 of 1972, as amended, which should be recognized for ability to support the health and growth of children in an environment that promotes emotional, intellectual and interpersonal understanding.

RESOLVED, That City Council hereby approve recognition of the Allen Creek Preschool as a local
