Resolution to Approve a Grant of Easement to the Malletts Creek Drainage District at Churchill Downs Park and Eisenhower Park (8 Votes Required)

The Washtenaw County Water Resources Commissioner (WCWRC) manages County drains in established drainage districts under the Michigan Drain Code of 1956. This easement is for a County drain that includes a regional stormwater basin that is part of the Malletts Creek Drainage District.
