AN ORDINANCE TO AMEND THE ZONING MAP, BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

[NORTH ADDITION] - PART OF LOT 2, "LANGFORD SUBDIVISION", A SUBDIVISION OF PART OF THE N. 1/2 OF SECTION 20, T. 2 S., R. 6 E. CITY OF ANN ARBOR, WASHTENAW COUNTY, STATE OF MICHIGAN, AS RECORDED IN LIBER 19, PAGES 46 THROUGH 48 OF PLATS, WASHTENAW COUNTY RECORDS MORE PARTICULARLY DESCRIBED AS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 2 AND PROCEEDING ALONG THE SOUTH LINE OF SAID LOT 2 AND LANGFORD SUBDIVISION S. 88°30'30" W. 275.17 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID SOUTH LINE S. 88°30'30" W. 322.69 FEET; THENCE ALONG THE WEST LINE OF SAID LOT 2 N. 01°29'30" W. 210.67 FEET; THENCE ALONG THE SOUTH RIGHT-OF-WAY LINE OF HURON VIEW BOULEVARD (66 FEET WIDE) 188.50 FEET ALONG THE ARC OF A CURVE TO THE LEFT, RADIUS 60.00 FEET, A CENTRAL ANGLE OF 180°00'15 AND A CHORD THAT BEARS N. 88°30'48" E. 120.00 FEET; THENCE S. 53°56'58' E. 61.01 FEET; THENCE S. 60°36'32" E. 179.81 FEET; THENCE S. 01°29'30" E. 81.19 FEET TO THE POINT OF BEGINNING, CONTAINING 1.12 ACRES MORE OR LESS.

[SOUTH ADDITION] - COMMENCING AT THE CENTER OF SECTION 20, TOWNSHIP 2 SOUTH, RANGE 6 EAST, CITY OF ANN ARBOR, WASHTENAW COUNTY, STATE OF MICHIGAN; THENCE N. 00°59′57″ E. 27.97 FEET ALONG THE NORTH-SOUTH 1/4 LINE OF SAID SECTION; THEN S. 79°10′22″ E. 401.84 FEET; THENCE S. 66°28′28″ E. 253.92 FEET; THENCE S. 19°16′57″ E. 264.59 FEET; THENCE S. 04°21′04″ E. 273.57 FEET FOR A PLACE OF BEGINNING; THENCE S. 89°11′00″ E. 45.56 FEET; THENCE S. 22°15′20″ W. 323.78 FEET; THENCE N. 48°38′00″ W. 60.00 FEET ALONG THE NOTHERLY RIGHT OF WAY LINE OF SUNSET ROAD (FORMERLY CALLED CHUBB ROAD); THENCE N. 22°15′20″ E. 71.33 FEET; THENCE S. 86°10′21″ E. 12.65 FEET; THENCE N. 10°17′46″ E. 57.93 FEET; THENCE N. 00°52′46″ W. 26.06 FEET; THENCE N. 64°52′11″ W. 52.19 FEET; THENCE N. 22°15′20″ E. 107.73 FEET; THENCE S. 89°11′00″ E.
