Resolution Recognizing the Ann Arbor Rowing Club (AARC) as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

The Ann Arbor Rowing Club (AARC) is a 501(c)3 non-profit organization that has a mission to provide and promote a safe, affordable, and educationally rewarding rowing experience for residents of Ann Arbor and the surrounding area. AARC is working to establish itself as one of the premiere community rowing associations in the Midwest. AARC offers a complete range of rowing programs from Learn to Row to Masters rowing.

Passage of the attached resolution will allow the Ann Arbor Rowing Club to hold a fundraising raffle at its annual Michigan Club Invitational Regatta on July 20. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
