Resolution to Approve the Weller Annexation, 0.5 Acre, 2119 Victoria Circle (CPC Recommendation: Approval -- 7 Yeas and 0 Nays)
Approval of this resolution will allow annexation of this vacant property from Ann Arbor Township into the City. The property is within the City's water and sewer service area, and the proposed use is consistent with the adjacent zoning, land uses and master plan. Council action on the proposed R1A (Single Family Dwelling District) zoning will be scheduled after the annexation process is complete.
