Resolution Accepting Water Main Easement at 2453 South Industrial Highway from John E. Green Co., Inc. **(8 Votes Required)**

Green Co., Inc. is the owner of property commonly known as 2453 South Industrial Highway, more fully described at Liber 2036, Page 707, Washtenaw County Records; and

Whereas, John E. Green Co., Inc. has executed and delivered a grant of easement for water mains and appurtenances, being more particularly described as:

Commencing at the Northeast corner of Lot 10 DEKONING SUBDIVISION, as recorded in Liber 21 of plats, Page 63, Washtenaw County Records; Being Part of the Southwest 1/4 of Section 4, Town 3 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan; thence S01°08'00"E 120.02 feet along the East line of said Lot 10; thence S87°43'00"W 154.51 feet for a **POINT OF BEGINNING;** thence continuing S87° 43'00"W 50.00 feet; thence N01°08'00"W 120.02 feet; thence N87°43'00"E 56.50 feet along the North line of said Lot 10; thence S37°53'42"W 26.20 feet; thence S01° 08'00"E 63.99 feet; thence N87°43'00"E 10.00 feet; thence S01°08'00"E 36.00 feet to the Point of Beginning. RESOLVED, That the City of Ann Arbor accepts this grant of easement.
