Resolution No. 3 Establishing a Public Hearing for Scio Church Sidewalk Special Assessment Attached for your review and approval is Resolution No. 3 establishing the date for the Public Hearing on the Scio Church Sidewalk - Special Assessment, District No. 43, File No. 2012-034.

The improvement includes the installation of a new sidewalk along the south side of Scio Church between Delaware Drive and Maple Road. Because most of this sidewalk fronts the rear lots of parcels or is along City-owned land, only three properties are assessable. Monies collected from Federal Surface Transportation Funds and the General Fund reduces the burden by special assessment funding at less than the standard rates.
