An Ordinance to Amend Chapter 55 (Zoning), Rezoning of 2.15 Acres from M1 (Limited Industrial District) to O (Office District), MAVD Financial Institution Rezoning, 2727 S. State Street (CPC Recommendation: Approval - 8 Yeas and 0 Nays) (Ordinance No. ORD-14-24)
Approval of this resolution will rezone this 2.2 acre parcel from M1 to O to allow construction of a 5,000 sq ft financial building with 4 drive-thru lanes on a currently undeveloped portion of the site.

MAVD FINANCIAL INSTITUTION REZONING (2727 SOUTH STATE STREET)

AN ORDINANCE TO AMEND THE ZONING MAP, BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the Southwest corner of Section 4, T3S, R6E, City of Ann Arbor, Washtenaw County, Michigan, thence N01°53′00″W 250.00 feet along the West line of said Section; thence N87°09′00″E 51.25 feet to a point on the Easterly right-of-way line of State Street, thence N02°03′20″W 792.64 feet along said right-of-way line to the POINT OF BEGINNING: thence continuing N02°03′20″W 73.44 feet along said right-of-way line; thence N87°01′00″E 315.13 feet; thence N42°01′00″E 90.17 feet; thence N87°01′00″E 237.17 feet; thence S01°53′00″E 137.22 feet; thence S87°01′00″W 111.62 feet; thence S01°53′00″E 178.60 feet; thence S87°01′00″W 175.00 feet; thence N01°53′00″W 178.59 feet; thence S87°01′00″W 327.99 feet to the POINT OF BEGINNING, being a part of the Southwest 1/4 of Section 4, T3S, R6E, City of Ann Arbor, Washtenaw County, Michigan and containing 2.15 acres of land, more or less. Being subject to easements and restrictions of record, if any.

in the City of Ann Arbor, Washtenaw County, Michigan as O (Office District).

<u>Section 2</u>. This ordinance shall take effect and be in force on and after ten days from legal publication.
