Resolution Authorizing Sanitary Sewer and Water Improvement Charges for 2550 Emerald Avenue (\$13,110.41)

Your approval is requested to levy sanitary sewer and water improvement charges totaling \$13,110.41 on the property known as 2550 Emerald Av. This vacant parcel was annexed 9/28/05.

According to current procedures, the property owner needs to now pay the property's share of the existing utilities through the City improvement charge levy as required under section 1:278(6), Chapter 12, of the Ann Arbor Code. The \$13,110.41 Utilities Improvement Charge is to be levied and then made payable in 11 annual installments. The sanitary sewer portion will accrue interest at 3.393% interest per annum on the unpaid balance. The water main portion will accrue interest at 2.999% interest per annum on the unpaid balance.

The sanitary sewer main in Emerald Av. was constructed by the City in 1969. The water main in Emerald Av. was constructed by the City in 1968.

It is therefore recommended that Council levy these improvement charges according to the terms described above.

1. That Council levy an improvement charge against the following property which is specifically benefited by the above improvements:

- That the improvement charge levied is \$13,110.41;
- 3. That this improvement charge is divided into 11 equal installments; the first installment to be due on June 1, 2015, and the 10 subsequent installments to be due on June 1 of each and every year thereafter, with the deferred installments of the improvement charge to bear interest at the rate of 3.393% per annum on sanitary sewer portion and 2.999% on the water main portion commencing June 1, 2015;
- 4. That the Public Services Area be directed to send a copy of this resolution by electronic mail or first class mail to the owners of the property and to promptly have this resolution recorded in the office of the Register of Deeds of Washtenaw County, Michigan; and
- 5. That this levied improvement charge is to be invoiced to the owner, Michael & Sarah S Tayter, of the property known as 2550 Emerald Av., City of Ann Arbor, Washtenaw County,
