Whereas, Green Road Retail, LLC, has signed a grant of easement for sanitary sewers and appurtenances, described as:

Commencing at the South 1/4 corner of Section 14, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan; thence N01°40'45"W 809.12 feet along the North-South 1/4 line of said Section 14; thence N69°00'35"E 760.72 feet along the Centerline of Plymouth Road (100 feet wide); thence N20°59'25"W 50.00 feet for a **PLACE OF BEGINNING**; thence S69°00'35"W 228.01 feet along the North Right-of-Way line of said Plymouth Road; thence N20°59'25"W 17.32 feet; thence N69°15'12"E 228.01 feet; thence S20°59'25"E 16.35 feet to the Place of Beginning.
