Whereas, Diequez Marsh Properties, L.L.C. is the owner of property commonly known as 3611 Plymouth Road, described at Liber 4586, Page 473 of Deeds, Washtenaw County Records; and

Whereas, Diequez Marsh Properties, L.L.C. has signed a grant of easement for water mains and appurtenances, described as:

Commencing at the South 1/4 corner of Section 14, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan; thence N01°40'45"W 809.12 feet (recorded as N00°05'50"E 810.08 feet) along the North-South 1/4 line of said Section 14; thence N69°00'35"E 760.72 feet (recorded as N70°54'30"E 759.87 feet) along the Centerline of Plymouth Road (100 feet wide); thence N20°59'25"W (recorded as N19°05'30"W) 50.00 feet along the Westerly line of tax parcel 09-09-14-400-009 for a PLACE OF BEGINNING; thence N20°59'25"W (recorded as N19°05'30"W) 193.06 feet along the Westerly line of tax parcel 09-09-14-400-009; thence 43.58 feet along the arc of a 108.00 foot radius circular curve to the left with a central angle of 23°07'05", having a chord which bears N32°32'58"W (recorded as N30°39'W) 43.29 feet along the Westerly line of tax parcel 09-09-14-400-009; thence 24.37 feet along the arc of a 65.00 foot radius circular curve to the left with a central angle of 21°28'56", having a chord which bears N37°10'56"E (recorded as N23°38'E) 24.23 feet along the Northerly line of tax

parcel 09-09-14-400-009; thence 53.62 feet along the arc of a 132.00 foot radius circular curve to the right with a central angle of  $23^{\circ}16'31''$ , having a chord which bears  $S34^{\circ}03'48''E$  53.25 feet; thence  $N69^{\circ}17'01''E$  14.34 feet; thence  $S20^{\circ}42'59''E$  40.00 feet; thence  $S69^{\circ}17'01''W$  14.11 feet; thence  $S20^{\circ}59'25''E$  156.37 feet; thence  $S69^{\circ}00'35''W$  24.00 feet along the North Right-of-Way line of said Plymouth Road to the Place of Beginning.

RESOLVED, That the City of Ann Arbor accepts this grant of easement.
