SPECIAL SESSION - SEPTEMBER 15, 1995

PUBLIC COMMENTARY - RESERVED TIME

LETTY WICKLIFFE - CITY ADMINISTRATOR

Letty Wickliffe, 1200 Earhart Rd., spoke in support of Roger Crum for the position of City Administrator. Ms. Wickliffe stated that Mr. Crum is highly qualified for the position and should not be rejected because of the comment he made regarding wife beating. She further stated that his rejection over such a comment is ridiculous, petty and appears to be political.

LELAHNI WESSINGER - CITY ADMINISTRATOR

Lelahni Wessinger, representing the Coalition for Common Sense in City Government, spoke in favor of Roger Crum for the position of City Administrator. Ms. Wessinger stated that Mr. Crum is highly qualified for the job and that she believes the reports of his aside about wife beating were blatant efforts to sandbag this candidate for political purposes.
