Attached is a resolution to approve the City of Ann Arbor Bryant Community Center Public Project. This project is included in the <u>PROS Plan</u>.

Petition Summary:

- A proposal to add an approximately 900 sq ft addition connecting the Bryant Community Center site with the single-family home located at 5 W. Eden Ct. The sites have been combined and are zoned PL.
- The proposed addition will match the existing materials and architecture of the building.
- No natural features are proposed to be disturbed from this proposal.
