Resolution to Approve the Carlberg Annexation, 0.17 Acres, 2501 Victoria Avenue (CPC Recommendation: Approval - 8 Yeas and 0 Nays)

Resolved, That the following described lands and premises situated and being in the Township of Pittsfield, Washtenaw County, Michigan, be detached from said Township and annexed to the City of Ann Arbor, to-wit:

Lot 34, Packard Hill Subdivision, part of the NE <sup>1</sup>/<sub>4</sub> of Section 4, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan; according to the plat thereof as recorded in Liber 6 of Plats, page 45, Washtenaw County Records.
