Whereas, Washtenaw Commons, LLC and NEJ-Washtenaw, LLC are the owners of property commonly known as 3500 Washtenaw Avenue, described at Liber 5065, Page 886 of Deeds,

Washtenaw County Records; and

Whereas, Washtenaw Commons, LLC and NEJ-Washtenaw, LLC have signed a grant of easement for water mains and appurtenances, described as:

Part of the N.E. 1/4 of Section 2, T.3S., R.6E., Pittsfield Township, Washtenaw Co., Michigan. Commencing at the North 1/4 Corner of Section 2; thence along the North-South 1/4 line of Section 2, S00°13'58"E, 1336.54 feet; thence N13°10'17"E, 192.11 feet; thence S77°01'11"E, 315.15 feet to the point of beginning; thence S77°01'11"E, 40.00 feet; thence S12°51'20"W, 51.96 feet; thence N77°08'40"W, 6.79 feet; thence S12°51'20"W, 98.23 feet; thence N77°08'40"W, 40.00 feet; thence N12°51'20"E, 138.23 feet; thence S77°08'40"E, 6.79 feet; thence N12°51'20"E, 12.04 feet to the point of beginning. Containing 0.14 acres, more or less.
