Whereas, BRE Nixon Road Associates, LLC, a Michigan limited liability company, is the owner of property commonly known as 3380 Nixon Road, Ann Arbor, Michigan 48105, described at Liber 4948, page 180 of Deeds, Washtenaw County Records; and

Whereas, BRE Nixon Road Associates, LLC, has signed a grant of easement for public right-of-way, described as:

Commencing at the S 1/4 Corner of Section 10, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan; thence N 89°56'13" E 1316.52 feet along the South line of said Section 10; thence N 00°11'20" W 1317.61 feet along the West line of the E 1/2 of the SE 1/4 of said Section 10 and the centerline of Nixon Road (variable width) to the POINT OF BEGINNING; thence continuing N 00°11'20"W 305.30 feet; thence N 89° 48'40" E 50.00 feet along the existing right-of-way line of said Nixon Road and the extension thereof; thence N 00°11'20" W 450.00 feet along said right-of-way line; thence S 89°48'40" E 10.00 feet along said right-of-way line; thence S 89°29'37" W 60.00 feet along the South line of the NE 1/4 of the SE 1/4 of said Section 10, T2S, R6E, City of Ann Arbor, Washtenaw County,
