Resolution to Approve the Purchase of One Etnyre 55-Ton Trailer from AIS Construction Equipment Corp. (MiDeal - \$77,952.60)

The attached resolution authorizes the purchase of one Etnyre Model RTN55ETD3 55-ton trailer at a cost of \$77,952.60 through the State of Michigan MiDeal cooperative purchasing contract #071B7700090 for use by the Public Services Area, Public Works Unit.

The trailer listed in this resolution will replace an existing 2000 Etnyre 50-ton trailer (#4362). The Public Works Unit uses this trailer for its streets maintenance operations to transport the paving mill equipment and other equipment as needed. Utilities operations uses it to transport its large excavator as well. In addition, it is used to haul concrete jersey barriers used for street closures.

AIS Construction Equipment Corp., New Hudson, Michigan was awarded contract #071B7700090 by the State of Michigan MiDeal cooperative purchasing program for Construction Equipment.

Adequate funding for the purchase of this equipment is available in the FY 18 approved Fleet Services Fund and Major Streets Funds.
