Resolution to Approve Amendment No. 1 to the Professional Services Agreement with TTL Associates, Inc. for Construction Materials Testing on the Crest, Buena Vista, Washington Water Main Project (up to \$20,001.00)

Attached for your review and approval is a resolution to authorize Amendment No. 1 to the Professional Services Agreement (RFP 18-02) with TTL Associates, Inc. (TTL) for construction materials testing on the Crest, Buena Vista, Washington Water Main Project.

Services being performed include all the required testing for soils, aggregates, asphalt, and concrete on the project that includes replacing 4 inch and 6 inch water main along Crest Avenue between Buena Vista Avenue and Huron Street, along Buena Vista Avenue between Crest Avenue and W Washington Street, and along W Washington Street between Crest Avenue and S Seventh Street with 8 inch and 12 inch water main. This project also includes bump-outs along W Washington and Crest, new ADA approved sidewalk ramps, some curb and gutter, drainage structure replacements, and HMA resurfacing.

The amount of testing performed on the Crest, Buena Vista, Washington Water Main Project has been higher than anticipated. The project took longer to complete than was anticipated, and as a result, additional testing is needed for the extra items of work.

TTL Associates, Inc. is in compliance with the requirements of the City's Non-Discrimination and Living Wage ordinances.
